Payment Information and Appointment Policy

Welcome to Coastal Physical Therapy! We would like to take this opportunity to review our billing and payment procedures with you. We will happily discuss your proposed care and answer any questions you may have relating to your treatment and insurance coverage before we begin therapy. We ask that you please take your time in reading our billing policies below.

PRIVATE INSURANCE

Coastal P.T. and Sports Rehab. will bill your insurance company for you for all your care one time only as a courtesy to you. You agree to give authorization of insurance benefits to be made directly to Coastal Physical Therapy and Sports Rehab. for services rendered. You agree to pay any portion of your bill not paid by your insurance company. You agree to be responsible for all your charges, even if you have insurance. All insurance co-payments are due at the time of your visit.

You are responsible to notify us immediately should any changes be made to your health insurance plan. Should you fail to do so, you agree to be responsible for all our charges that are not covered by your insurance.

Coastal Physical Therapy and Sports Rehab mails patient statements at the beginning of every month. If there is any unpaid balance on your account, you will receive a patient statement. Payment is due upon receipt of your statement. If payment is not received by the following month, you will receive a second notice statement, and then a final Notice statement. If we do not receive a payment within 10 days of a Final Notice statement, your account will be sent directly to our collection agency without further notice. In the event of default, you agree to pay all costs of collection and reasonable attorney's fees.

WORKERS COMPENSATION

We will obtain authorization to treat you from your employer's insurance carrier before we begin treatment. You are responsible for making and keeping your own appointments. Carriers will be notified of missed appointments. If you fail to make or keep scheduled appointments, your treatment will be discontinued.

THIRD PARTY BILLING, LIENS AND LEGAL CASES

Third party billing is not accepted at Coastal Physical Therapy and Sports Rehabilitation, patients with third party payers are responsible for paying for their services and obtaining reimbursement on their own. Leins and legal cases are accepted at Coastal Physical Therapy and Sports Rehab. on a case by case basis. Upon approval of those cases, patients and attoreny's will be required to sign a lein agreement prior to any services being performed.

MEDICARE

Coastal Physical Therapy and Sports Rehab. has been approved as an official certified Medicare Facility. This means that we will bill Medicare for you, we agree to Medicare's rates, and Medicare will send your benefits directly to us. You agree to be responsible for any deductible, co-payment or other charges or items or services denied by Medicare.

Medicare requires you to obtain a new prescription for your treatment every 90 days. We will not be able to continue treatment until a current/updated prescription has been received.

APPOINTMENT / NO SHOW POLICY

We are happy to allow you to schedule your treatment time in advance if you wish. If you find that you are unable to keep an appointment, **please notify us at least 24 hours in advance**. **Late arrival of more than 10-15 minutes may result in shortened treatment or cancellation.** We reserve the right to bill you if you fail to keep a pre-scheduled appointment, or if you cancel less than 24 hours notice, except in cases of true emergency or illness. **Our customary fee of \$50.00 will be charged to your account for broken pre-scheduled appointments. This charge will not be billed to your insurance company. You agree that these charges will be solely your responsibility. No Show fees must be paid before your next scheduled.** Patient Initials: _____

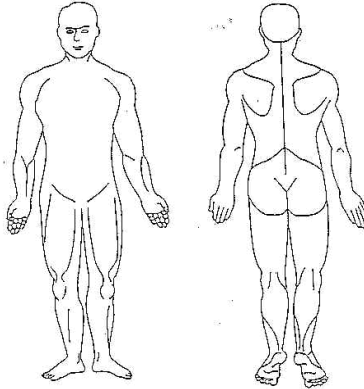
